Comes your Complainant, Florence Earle Thomas, and files this her Bill of Complaint for divorce against James Abbot Thomas, and respectfully represents and shows unto your Honor:

- 1. That the Complainant is over the age of twenty-one years and is a resident citizen of the State of Alabama, Baldwin County; that the Respondent is over the age of twenty-one years and is a resident of the State of Alabama, Baldwin County.
- 2. That the Complainant and Respondent were lawfully married on, to-wit, June 25, 1947.
- 3. The Complainant further avers that the Respondent has committed actual violence on her person attended with danger to her life and health and from hes conduct she is reasonably apprehensive of other and further violence, so much so that she can no longer live with the Respondent; that the Respondent has made numerouse threats of doing her physical harm and from his manner and conduct toward her she is reasonably convinced that he will commit actual violence on her person attended with danger to her life or health.
- 4. Complainant further shows unto your Honor that the Respondent has, since their marriage, become addicted to habitual drunkenness, and the said habit continues to this date.
- 5. Complainant further shows unto the Court that there was born of this marriage two children, namely, Virginia Ann Thomas, age  $4\frac{1}{2}$  years and William Bruce Thomas, age  $1\frac{1}{2}$  years, which said children were in the custody and control of the Complainant until they were forcibly removed from her sustody and control and are being forcibly withheld.
- 6. That on the 8th day of January, 1952, the Complainant and Respondent jointly purchased property in Baldwin County, Alabama,

described as follows:-

Commencing at the point of intersection of the North line of Section thirty-three (33), Township seven (7), South, Range four (4) East, of St. Stephens Meridian, Baldwin County, Alabama, with the East line of the right-of-way of the L & N Railroad, said point being one hundred (100) feet East of the Northwest corner of said Section thirty-three (33), run thence South twenty (20) feet and East four hundred seventeen (417) feet to a point; thence South five hundred (500) feet to a point for a beginning corner, thence run East one hundred sixty-six (166) feet to a point, thence run South three hundred eighty-one (381) feet to a point, which is also the Northeast corner of property owned by G. H. Bonie, thence run West one hundred sixty-six (166) feet along the North line of the property of said G. H. Bonie to a point, thence run North three hundred eighty-one (381) feet to the point of beginning.

That they have constructed thereon a small dwelling which has been constructed and paid for partially with monies of the Complainant. Complainant further shows that she has insufficient funds with which to employ counsel to represent her in this proceeding and believes the Respondent to be financially able to pay for this representation and believes him financially able to pay the sum of Fifty Dollars (\$50.00) per month for the support and maintenance of each of the minor children of this marriage.

THE PREMISES CONSIDERED, Your Complainant prays that James Abbot Thomas be made a party defendant of this cause by the usual process, of this Honorable Court, requiring him to plead, answer or demur within the time and under the penalties prescribed by the rules of this Court and the Statutes in such cases made and provided; that upon a final hearing of this cause that she be granted a divorce from the said Respondent; Complainant further prays that she be awarded as full settlement of alimony the property hereinabove described; that she be awarded custody and control of the minor children of this marriage and that she be awarded the sum of Fifty Dollars (\$50.00) for the maintenance and support of each of the minor children, and that she further be awarded such sum as to the Court may seem just and proper as payment to her Solicitor in this behalf and that she be mistaken in the relief prayed for, that she be granted such other, further, different and general

relief to which she may be entitled and as in duty bound she will ever pray.

- 3. The respondent and cross-complainant further avers that the complainant and dross-respondent has committed actual vio-lence on his person attended with danger to his life and health and from her conduct he is reasonably apprehensive of other and further violence, which would necessarily endanger his life or health; that she has made numerous threats of doing him physical harm and from her manner and conduct thward him he is reasonably convinced that she will commit actual violence on his person attended with danger to his life or health.
- 4. Your cross-complainant further avers and alleges that said cross-respondent has been guilty of adultery with divers parties and persons whose names are unknown to your cross-complainant.

Now comes your Petitioner, Florence Earle Thomas, the Complainant in the above styled cause, and respectfully shows unto the Court:-

- 1. This cause coming on to be heard was submitted upon the original bill of complaint; answer and cross bill and testimony of the witnesses on behalf of the complainant and respondent taken ore tenus, and upon consideration thereof, the Court is of the opinion that the Complainant is entitled to a divorce from the Respondent.

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED by the Court that the bonds of matrimony heretofore existing between the Complainant and the Respondent be, and the same are hereby dissolved, and that the said Florence Earle Thomas is forever divorced from the said James Abbot Thomas for and on account of cruelty.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that neither party to this suit shall again marry except to each other until sixty days after the rendition of this decree, and that if an appeal is taken within sixty days, neither party shall again marry except to each other during the pendency of said appeal.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED by the Court that for a period of six months hereafter, that the custody and control of the minor children of this marriage, namely, Virginia Ann Thomas, aged four and one half years, and William Bruce Thomas, aged one and one half years, shall be in the custody and control of their paternal grandparents, Bruce Abbot Thomas and Erna May Thomas, Foley, Alabama, provided, however, that the Complainant, Florence Earle Thomas, shall have the custody and control

of said children from the time she leavesher place of employment Thursday afternoon until 8 A.M.
