This cause coming on to be heard was submitted upon Bill of Complaint, Decree Pro Confesso on Answer and Waiver and Testimony as noted by the Register, and upon consideration thereof, the Court is of the opinion that the Complainant is entitled to the relief prayed for in said bill.

It is therefore ordered, adjudged and decreed by the Court that the bonds of matrimony heretofore existing between the Complainant and Defendant be, and the same are hereby, dissolved, and that the said

Josephine Coleman is forever divorced from the said Timothy Coleman for and on account of

Voluntary Abandonment.

It is further ordered, adjudged and decreed that neither party to this suit shall again marry except to each other until sixty days after the rendition of this decree, and that if appeal is taken within sixty days, neither party shall again marry except to each other during the pendency of said appeal.

It is further ordered that the Complainant and Respondent be, and they are hereby permitted to again contract marriage upon the payment of the cost of this suit.

It is further ordered that Defendant, Timothy Coleman the Respondent pay the cost herein to be taxed, for which execution may issue.

Comes JOSEPHINE COLEMAN, by this her bill of complaint,
presented against TIMOTHY COLEMAN, and respectfully shows:

FIRST: Complainant is twenty years of age and Defendant
is over the age of twenty-one years and both are now and have been
for more than three years next preceding the filing of this bill of
complaint bona fide residents of Baldwin County, Alabama, Complainant
living at Point Clear and Defendant living at Battles Wharf, both in
Baldwin County, Alabama.

SECOND: Complainant and Defendant were married in Pasca-
goula, Mississippi, on or about the 23rd day of December, 1952.

THIRD: That Complainant and Defendant have lived together
as husband and wife up until on or about the 24th day of April, 1953,
but have not lived together since. That on or about the 23rd day of
April, 1953, the Defendant voluntarily abandoned the bed and board
of this Complainant and said abandonment has been continued since that
time.

FOURTH: There have been no children born to this marriage.

THE PREMISES CONSIDERED, Complainant prays that Timothy
Coleman be made party defendant to this bill of complaint by proper
process and required to plead, answer or demur to this bill within
the time prescribed by law.

Complainant further prays that upon a final hearing of
this cause a decree be rendered forever divorcing her from the said
Timothy Coleman and granting her the right to remarry and change her
name should she do desire, and to such other, further or different
relief as to equity may seem meet.

Respondent further agrees that this cause may be submitted for final decree at any time on the pleading and Complainant's evidence as noted by the Register.



My name is Josephine Coleman and I am filing this bill for divorce against Timothy Coleman. I am 20 years old and was born and have lived in Baldwin County all my life. My husband was born and raised here too. I am now living at Point Clear and my husband is living at Battles Wharf. Both of us have been living here in Baldwin County for the last three years and are still living here. We were married over in Pascagoula, Mississippi, on the 23rd of December, 1952, and lived together up until about the 23rd of April, 1953, when he left me. On or about the 23rd of April, 1953, he left me and we have been living separate and apart since that time, and this abandonment has lasted over a year. We have had no children and I am asking for a divorce from Timothy Coleman. I am not asking him for any support.

My name is Anderson Quaites and I live at Point Clear. I have known Josephine Coleman and her husband, Timothy Coleman, for all their lives.
