SETTLEMENT AND PETITION

The undersigned, being the only parties in the above entitled matter, hereby petition the Court for approval of the following agreement and settlement, and agree and represent to the Court as follows:

1. That they are subject to the provisions of the Workmen's Compensation Law of Alabama. That the said employee, aged 45, residing at Silverhill in Baldwin County, Alabama, who can read and understand the English language, did on the 1st day of September, 1967, sustain an injury by accident while employed by said employer, which injury occurred at Fairhope, Alabama, and resulted in permanent partial disability of said employee and consisted of 70% permanent partial loss of use of the left index finger.

That said employee was receiving, at the time of injury, wages at the rate of ONE HUNDRED THIRTY-TWO (\$132.00) DOLLARS per week.

Therefore, it is hereby agreed that the employee is entitled to and shall receive compensation for said injury from the employer beginning September 1, 1967 at the rate of FORTY-FOUR (\$44.00) DOLLARS per week during disability for forty (40) weeks payable as follows: The sum of ONE THOUSAND SEVEN HUNDRED THIRTY-THREE AND 15 (\$1,733.15) DOLLARS which is the commuted value in a lump sum settlement discounted at 4% for a lump sum settlement, and is the combined total of compensation commuted to be paid, all subject to the limitations of said act, and the employee agrees to give proper receipts for each payment made hereunder.

The employee acknowledges that he has received to date medical and surgical treatments and benefits given by said Act and the employer agrees to continue to furnish the same, if any be necessary to the extent and in the manner required by said Act. The employee agrees to present himself for examination, or if physically unable to do so, to submit to examination by the physican or physicans designated by the employer, when requested. This settlement contains the whole agreement between the parties hereto.
