



TO THE HONORABLE F. W. HARE, JUDGE OF THE CIRCUIT COURT OF BALDWIN COUNTY, ALABAMA, SITTING IN EQUITY:

Your Orator, Henry Hawkins, presents this Bill of Complaint against Martha Hawkins and thereupon your Orator complains and shows unto the Court and your Honor as follows:

1. Your Orator is over twenty-one years of age and a bona fide resident citizen of Baldwin County, Alabama, where he has resided all of his life. The Respondent, Martha Hawkins, is over twenty-one years of age and a resident of Plateau, in Mobile County, Alabama.

2. Your Orator and the said Respondent were lawfully married by a minister of the gospel in Mobile, Alabama during the summer of 1940 and lived together as man and wife until on to-wit, June, 1942, when the Respondent voluntarily abandoned your Orator without fault on his part. Your Orator and the said Respondent have not lived together since the said date.

PRAYER FOR PROCESS

Your Orator prays that the Court will take jurisdiction of the cause made by this Bill of Complaint, that due notice thereof be given the Respondent, Martha Hawkins, in the form and manner prescribed by law, requiring her to plead, answer or demur to the Bill of Complaint within the time and under the pains and penalties prescribed by law and the practice of this Honorable Court.

PRAYER FOR RELIEF

Your Orator prays that upon a final hearing of this cause the Court will make and enter a proper order or decree dissolving the bonds of matrimony now existing between your Orator and the said Respondent and granting unto him the right to marry again. Your Orator prays for such other, further and general relief as he may be equitably entitled to the premises considered.
