In the 2nd day of June, the Respondent did actual violence to my person by striking me with his hand; that the conduct and actions of the Respondent necessarily endangered my life and health; that the conduct of the Respondent was such as to give me every reasonable apprehension to believe, and I did actually believe, that he would carry out his threats and do further violence to my person which would necessarily endanger my life and health.

We have no children.

Thula Duck, a witness for the Complement being first duly sworn, deposes and says:

My name is Thula Duck. I live in Bay Minette, Baldwin County, Alabama. The Complainant is the above styled cause is my daughter.

I have had occasion to be around and with the Complainant and the Responder quite often while they were living together as husband and wife.
