

Dear Mrs. Duck:

We attach hereto International Paper Company check No. 43402 in the amount of \$363.14 representing deductions made from the wages of Bradford Williams in accordance with garnishment issued by you for the First National Bank of Bay Minette, Alabama. The total amount of the garnishment, including Court Cost, was \$408.70 as per copy of same attached. We understand, however, from Attorney J.
