Now comes your Complainant, Ljuba Schwandt, and humbly complaining against the Respondent, Gustave Schwandt, respectfully represents and shows unto your Honor and this Honorable Court as follows:

l.

That the Complainant is over 21 years of age, and a bona fide resident of Baldwin County, Alabama; that the Respondent is over 21 years of age, and a non-resident of the State of Alabama, his address being c/o Philadelphia Home for the Aged, 7023 Rising Sun Avenue, Philadelphia, Pennsylvania; that the Complainant has been a bona fide resident of Baldwin County, Alabama, for more than one year next preceding the filing of this Bill of Complaint;

That the Complainant and Respondent married at Lillian, Baldwin County, Alabama, November 30, 1939; that they lived together as husband and wife in Baldwin County, Alabama, until February, 1940;

That in February, 1940, the Respondent voluntarily abandoned the bed and board of the Complainant, and has remained away voluntarily and continuously since that time.

WHEREFORE, the premises considered, your Complainant prays that your Honor will, by proper process, make the said Gustave Schwandt party respondent to this bill of complaint, requiring him to plead, answer or demur to the same within the time and under the penalties prescribed by law and the practice of this Honorable Court.

Complainant further prays that upon a final hearing of this cause an order and decree be made granting to him an absolute decree of divorce, forever barring the bonds of matrimony existing between her and the Respondent; that your complainant prays for such other, further different and general relief as she may be in equity and good conscience entitled to receive, and sain duty bound she will ever pray.
