Now comes your Complainant, Mitt Woodard, and humbly complaining against the Respondent, Leila Donaldson, respectfully represents and shows unto your Honor and this Honorable Court as follows:

That the Complainant and Respondent are both bona fide residents of Bay Minette, Baldwin County, Alabama, and over 21 years of age;

That your Complainant and the Respondent own as joint tenents or tenants in common the following described personal property situated in Bay Minette, Baldwin County, Alabama, to-wit: The Theater Cafe including refrigerators, cash registers,

gas range, counters, stools, dishes, kitchen utensils and all other equipment used in connection with the said Cafe;

That the Complainant owns an undivided three-fifths (3/5) and the Respondent an undivided two-fifths (2/5) in and to said equipment;

That the Complainant has necessarily had to employ counsel to prosecute this suit, and is to the common benefit of both the Complainant and Respondent;

WHEREFORE the premises considered, your Complainant prays that your Honor will by the proper processes, make the said Leila Donaldson party respondent to the Bill of Complaint requiring her to plead, answer or demur to the same within the time and under the penalties prescribed by law and the practice of this Honorable Court.

and enter an order and decree that the said property cannot be equitably divided between the owners thereof and ordering it to be sold in accordance with the statues of the State of Alabama; that your Honor will fix a reasonable attorney's fee to be paid to be paid to the Complainant attorney in the prosecution of this suit; that your Honor will grant to the Complainant such other, further different and general relief as he may in equity and good conscience entitled to receive, and as in duty bound he will ever pray.
