




Now come the Defendants and for answer to the complaint heretofore filed in this cause and to both counts thereof, state as follows:

Strom, and acting within the line and scope of his authority, on a public road in Baldwin County, Alabama, to-wit, the intersection of Byrne Street and Clay Street, within the city limits of Bay Minette, Alabama, and at the said time and at said place, the said Defendant, Patrick Robert Strom so negligently operated the automobile which he was then and there driving, so as to cause of allow the same to collide with an automobile operated by a third party and as a proximate consequence of the negligence of the Defendant, Patrick Robert Strom, who was then and there the agent, servant or employee of the Defendant, Patricia P. Strom, and acting within the line and scope of his authority, the Plaintiff was injured in this: he received bruises and a contusion of his right hip; he required hospitalization and was caused to undergo other medical treatment and incurred pain and suffering, all to the damage of the Plaintiff aforesaid, hence this suit.

COUNT TWO:


The Plaintiff claims of the Defendants the sum of ONE THOUSAND DOLLARS (\$1,000.00) for that theretofore, on, to-wit,
