The Plaintiff claims of the Defendant FORTY FIVE AND 80/100 DOLLARS (\$45.80), the balance due by promissory note made by him on the 12th day of October, 1962, and payable on the demand of the Plaintiff after November 15, 1962, with interest thereon from date at the rate of seven percent (7%) per annum.


