- l. The Respondent, Cora Lee Armstrong, is a married woman over eighteen years of age, whose residence and post office address is Bay Minette, Alabama.
- 2. Your Orator and the said Respondent were lawfully married on, to-wit, March 31, 1941, and lived together as man and wife in Baldwin County, Alabama until on, to-wit, October 3, 1942, when they separated.
- 3. Immediately prior to the said separation, the said Respondent, Cora Lee Armstrong, committed adultery with Roosevelt Valree, after which your Orator separated from her and has not lived with her since the said date.

PRAYER FOR PROCESS

Your Orator prays that the Court will take jurisdiction of the cause made by this Bill of Complaint, that due notice thereof be given the Respondent, Cora Lee Armstrong, in the form and manner prescribed by law, requiring her to plead to, answer or demur to the Bill of Complaint within the time and under the pains and penalties prescribed by law and the practice of this honorable Court.

PRAYER FOR RELIEF

THE PREMISES CONSIDERED, your Orator prays that upon a final hearing of this cause, the Court will make and enter a proper or decree dissolving the bonds of matrimony now existing

between your Orator and the said Respondent, granting to him the right to marry again. Your Orator further prays for such other, further and general relief as he may be equitably entitled to, the premises considered.
