

The Plaintiff claims of the Defendant the sum of THREE HUNDRED EIGHTEEN AND 80/100 DOLLARS (\$318.80), the balance due by promissory note made by him on October 6, 1967, and payable in 11 monthly installments of \$37.00 each and one final installment of \$31.00, commencing on November 10, 1967, together with the interest thereon from April 10, 1968, at the rate of eight percent; Plaintiff further alleges that in and by the terms of said note the failure to pay any installment accelerated the balance due under said note, and that said Defendant defaulted in his obligation to pay the installments as set out hereinabove.

Plaintiff further alleges that in and by the terms of said note, the Defendant waived all rights of homestead under the Laws of the State of Alabama, and Plaintiff claims the benefit of said waiver.

Plaintiff further alleges that in and by the terms of said note, the Defendant agreed to pay all costs of collection, including a reasonable attorney's fee, and Plaintiff claims the further and additional benefit of a reasonable attorney's fee in the premises.
