Plaintiff claims of the defendants, jointly and severally, the sum of \$564.73, for that heretofore on to-wit: May 26, 1967, the defendants executed a written conditional sales contract, a copy of which is attached hereto and made a part hereof as if fully set out herein, wherein they agreed to pay Electronic Products, the sum of \$461.83, in stallments of \$12.82, per month, commencing on to-wit: June 15, 1967, including interest, which said contract was transferred and assigned to plaintiff herein before default occurred in said contract. Plaintiff avers that defendants defaulted in payment thereunder on to-wit: October 18, 1967, and pursuant to the terms of said contract the plaintiff has declared the entire balance due and owing.

Plaintiff avers that by the terms of said contract the defendants waived all right or claim of exemption under the Constitution and Laws of the State of Alabama and agreed to pay a reasonable attorney's fee in the event employment of an attorney was necessary for the collection, which said attorney's fee plaintiff claims in the amount of \$141.18, which is one-third of \$423.55.

WHEREFORE, Plaintiff claims of defendants, \$423.55, plus interest, plus attorney's fee of \$141.18, as aforesaid.


