We received Garnishment on Judgment #8357 $\frac{1}{2}$  on June 25, 1969 at 4:50 PM. This garnishment concerns Hales, Inc. VS Leonard McCants.

Leonard McCants is employed by us as a laborer earning \$1.60 per hour. He normally works thirty five to forty hours per week.

We contacted E. G. Rickarby, Attorney for Hale's, Inc. and made an agreement with him where we would withhold \$5.00 per week from Leonard McCants paycheck in payment on this garnishment. These withholdings will be mailed to you once a month starting the last week in July. The \$5.00 withholdings will start the first pay period in July and will continue until the garnishment is paid in full or this employee is no longer working for us.
