

Count I.

The Plaintiff claims of the Defendant SIX HUNDRED SIXTY-SIX AND 75/100 (\$666.75) DOLLARS due from him by account on, to-wit, the 23rd day of August, 1967, which sum of money with the interest thereon is still unpaid. The account sued on is evidenced by an itemized and verified statement filed herewith.

Count II.

The Plaintiff claims of the Defendant the sum of SIX HUNDRED SIXTY-SIX AND 75/100 (\$666.75) DOLLARS due from him by account stated between the Plaintiff and the Defendant on, to-wit, the 23rd day of August, 1967, which sum of money with the interest thereon is still unpaid.


Count III.

The Plaintiff claims of the Defendant the sum of SIX HUNDRED SIXTY-SIX AND 75/100 (\$686.75) DOLLARS due from him for goods, wares and merchandise sold by the Plaintiff to the Defendant on, to-wit, the 23rd day of August, 1967, which sum of money with the interest thereon is still unpaid.

Count IV

The Plaintiff claims of the Defendant the balance of SEVEN HUNDRED SIXTY-SIX AND 75/100 (\$786.75) DOLLARS due by promissory note made by him on the 2nd day of March, 1967, and due ninety days from date, with interest at 7% per annum to maturity.

And the Plaintiff avers that in said note and as a part of the consideration thereof, the Defendant has expressly waived his rights to claim personal property as exempt to him under the Constitution and laws of the State of Alabama, and has agreed to pay an attorney's fee for the collection thereof, and the Plaintiff hereby claims the further sum of ONE HUNDRED AND NO/100 (\$100.00) DOLLARS as such attorney's fee.

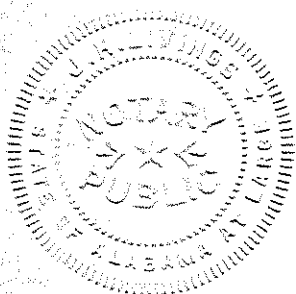
