DEPOSITIONS OF WILLIE GRAY JOHNSON and ALICE JACKSON, WITNESSES FOR COMPLAINANT

The said witnesses, being duly sworn upon examination by Solicitor for Complainant, testified as follows:

WILLIE GRAY JOHNSON

I am the Complainant in this cause and on August 31, 1935 was married to Doris Johnson at Bay Minette and lived together with him until the middle of June 1944 in Baldwin County when we separated. We are both over the age of twenty-one years and life long residents of Baldwin County.

Although we have four children and got along fairly well for a long time in late months his attitude has changed and he has been unreasonable and cruel. He has repeatedly struck me and beaten me but I put up with this up to June 15th last, when he attacked me and cut me with a knife severely in the back. Since then I left him and have not gone back to him as I feel to do so would endanger my life.

We have four children; Doris, Jr., aged 7 years, K. C., aged 5, Frances Carroll, aged 4, and the baby, Dorothy Marie, 7 months old. The older three of these children are still with my husband's parents at Bay Minette and I have the baby with me. My husband has agreed to let me have the custody of all the children for one year; after which if we cannot agree about the disposal of them the matter is to be decided by this Court. He has also agreed to pay \$15.00 per month for their support to his mother who will use it in buying the things that I tell her are needed for the children. He also agreed that should he be called into the Army his allotment and allowance for the children should be paid to his mother who be applied for their use under my directions.

ALICE JACKSON

I am a resident of Fairhope, Alabama, and have known Willie Gray Johnson for about eight years. I knew her before she was married and have kept in touch with her ever since upup touch the time they parted she and her husband lived about a mile away from me and I have been quite intimate with them. I have repeatedly heard him fussing and quarreling with her apparently without cause. About the middle of June I saw Willie Gray who showed me a serious cut made by a knife across her back which she told me had been given her by her husband. She came to my house from hers and was bleeding from this cut. She told me that she had stood his treatment as long as she could and was now leaving him and since that time she has lived apart from him. In my opinion if she went back to live with him he would do her serious harm for he is hot tempered and quarrelsome.

TO THE HONORABLE F. W. HARE, JUDGE OF THE CIRCUIT COURT
OF BALDWIN COUNTY, ALABAMA: IN EQUITY.

Comes WILLIE GRAY JOHNSON, and by this her Bill of Complaint, presented against DORIS JOHNSON, respectfully shows:

FIRST: That Complainant and Defendant are both over the age of twenty-one years and have been all of their lives, bona fide residents of Baldwin County.

SECOND: That Complainant and Defendant were married on August 31, 1935 at Bay Minette, and have lived together since in this County until the middle of June, 1944, when they parted because of his treatment of her.

THIRD: For number of months past, the attitude of Defendant toward Complainant has been unreasonable and cruel. He has repeatedly struck and beaten her, which she endured up to June 15th. last when Defendant attacked her and cut her severely in the back, whereupon, she has left him and has lived separate and apart without resumption of marital relations, fearing for her life should she continue to live with him.

FOURTH: That four children were born to this marriage, the oldest about twelve and the youngest, a daughter, a nursing infant but a few months of age, who now lives with Complainant. The three older children since the separation being with the father's relations.

THE PREMISES CONSIDERED, Complainant prays that Doris Johnson be made party Defendant to the cause, and by proper process required to answer this Bill within the time required by Law.

Complainant further prays that upon the hearing of this cause a decree be rendered forever divorcing her from said Doris Johnson, granting her the right to marry again should she so desire, the custody of the children of the marriage, and such other, further or different relief as to equity may seem meet.

It is further ordered, adjudged and decreed that neither party to this suit shall again marry except to each other until sixty days after the rendition of this decree, and that if appeal is taken within sixty days, neither party shall again marry except to each other during the pendency of said appeal.
It is further ordered that the Complainant and Respondent be, and they are hereby permitted to again contract marriage upon the payment of the cost of this suit.
It is further ordered thatDORIS JOHNSON
the Respondent pay the cost herein to be taxed, for which execution may issue.
