2. That the plaintiff have and recover of the defendants the costs in this behalf expended, for all of which let execution issue.

That the Clerk of this Court shall forthwith certify this judgment in such proceeding, together with all the papers and documents, including the original will, heretofore certified to this court by the probate court, back to the probate court from which they were first carried, in all respects as required by Code 1940, Title 61, Section 63.
