The Plaintiff claims of the Defendant Six Hundred Forty-Four and 87/100 (\$644.87) Dollars, damages for the breach of a covenant, or agreement entered into by him on or about the lst day of March, 1967, in substance as follows, to-wit:

Defendant, together with Plaintiff and the three other heirs of their deceased father, Ed. J. Havel, who died intestate in 1966, signed certain legal documents permitting Garfield Hayes and Zena Hayes, who were indebted to the deceased Ed. J. Havel, Deceased, and upon receipt of said sum Defendant agreed to disburse one-fifth (1/5) thereof to Plaintiff as his legal share of said sum due to the Estate of Ed. J.
