Oral examination before the Register of the following witnesses:

Harding G. Fillmore

who reside in Alabama, said examination being conducted in Bay Minette Alabama,

on this the 24th day of January, 1956, and there being present

Howard J. Kearley, attorney for complainant, and Wilson Hayes, Guardian ad Litem for the respondent Marion Edith Fillmore.

The said witness being first sworn to speak the truth, the whole truth and nothing but the truth, testified as follows:

My name is Harding G. Fillmore. I am the complainant in this case. I am a citizen of the state of Alabama, and Marion Edith Fillmore is also. She is now confined as an insane patient in Bryce Hospital, Tuscaloosa, Alabama. Before she became insane, we lived together in Baldwin County, Alabama. She was committed to Bryce Hospital under committment by the Probate Judge of Baldwin County.

The respondent Marion Edith Fillmore and I were married to each other in the year 1937, and lived together, as husband and wife, principally in Baldwin County, Alabama, until the year 1949, when she bacame insane. After several short previous committments, she was finally committed to Bryce Hospital as insane, on June 7, 1950, and has been continuously confined there since. She has been confined to said insane asylum as an insane patient for more than five years before this suit was filed.

Through my attorney, I have obtained a statement of Dr. J.S. Tarwater, superintendent of the said Bryce Hospital where my wife, Marion Edith Fillmore is confined, made under his oath, in which he certifies that after long observation and full and complete study, it is his opinion that Marion Edith Fillmore is hopelessly and incurably insane. His certificate bears jurat dated June 13, 1955, and I file it herewith as an exhibit to my testimony. On the basis of my own knowledge of her condition, and on the basis of Dr. Tarwater's certificate, I state that Marion Edith Fillmore is confined in Bryce Hospital, and is hopelessly and incurably insane, and that she has been confined there as insane for more than five years prior to the commencement of this suit, and has been insane all that time.





Dear Mrs. Duck:

I have a notice from Judge Hall that all equity cases will be called and dismissed unless tried or definite arrangements are made for definite trial, on the regular call of the trial docket on January 17th. I have a case on your equity docket: HARDING G. FILLMORE V. MARION EDITH FILLMORE, a divorce case, which I filed last June. My client is a pilot on a river boat on the Mississippi, and gets back here only about once every two or three months. The bill of complaint of Harding G. Fillmore, exhibited in
the Circuit Court, in Equity, against Marion Edith Fillmore.

Humbly complaining, your orator shows unto your Honor as follows:

1. Your orator is over the age of twenty-one years and is a
citizen of the State of Alabama; the respondent Marion Edith
Fillmore is a resident of the State of Alabama, and she is of
unsound mind.
2. Your orator and the respondent Marion Edith Fillmore were
married to each other in the year 1937 and thereafter lived to-
gether as husband and wife, principally in Baldwin County, Alabama.
In the year 1949, while your orator and respondent were living to-
gether in Baldwin County, Alabama, the respondent became insane, and
after several previous short committments, was on June 7, 1950,
committed to Bryce Hospital for the insane, and she has been con-
tinuously confined in said insane asylum for a period of more than
five years next preceding the filing of this bill of complaint
and is hopelessly and incurably insane at the time of the filing
of this bill, and your orator avers that Dr. J.S. Tarwater,
superintendent of said insane asylum has made a certified statement
under oath that it is his opinion after long observation and full
and complete study that the said Marion Edith Fillmore is hope-
lessly and incurably insane. The separation of your orator and
the respondent on account of respondent's insanity occurred in
Baldwin County, Alabama.

Wherefore, your orator prays that the said Marion
Edith Fillmore may be made a party respondent hereto, and that
summons may be issued and served upon her requiring an answer under
the rules of this Court, and that a guardian ad litem may be
appointed to represent and defend her in this proceeding; and upon
a final hearing, your orator prays that by the decree of this Court
he may be granted an absolute divorce.
