STIPULATION

It is stipulated and agreed by and between the parties hereto as a property division in lieu of alimony that Prue P. Applequist has this day transferred to Oren V. Applequist all in his interest in any personal property now in the possession of the said Prue P. Applequist; that the parties have also agreed between themselves as follows:

That Prue P. Applequist should have the care, custody and control of the children named in the Complaint, with the right of the Respondent, Cren V. Applequist to visit them at reasonable and proper times. That the Respondent, Cren V. Applequist, may, if the children consent, have custody and control of the said children for a period of Six (6) weeks during the summer months. Provided that the said Respondent shall assure the Complainant that he has a proper and suitable place in which the said children shall reside.

That the Respondent, Oren V. Applequist, should pay the Complainant, Prue P. Applequist, the sum of Twenty-five (\$25.00) Dollars a week, beginning at the date of these presents, except during that period when the said children are in his care and sustody. That should the Complainant have, for the children, serious medical expenses in the future, the Respondent agrees to pay the amount of such expenses.

Comes your Complainant, Prue P. Applequist, and files this her Bill of Complaint for divorce against Oren V. Applequist, and shows unto your Honor and unto this Honorable Court as follows:

FIRST:

That your Complainant and the Respondent are over the age of twenty-one years, and that your Complainant is a resident citizen of Baldwin County, Alabama, residing at Fairhope, and the Respondent is a resident of the state of New York.

SECOND:

That your Complainant and the Respondent were married on heretofore, to-wit, Nov. 20, 1940 at Bristolville, Ohio, and lived together as man and wife until on, to-wit, August 31, 1954, when, on account of the matters hereinafter complained of, your Complainant was compelled to live separate and apart from the Respondent; that in August, 1954 and at times prior thereto, the Complainant states that the Respondent committed acts of violence on her person, attended with danger to her health and life; Complainant avers and charges that Respondent has made numerous

threats of doing her physical harm and from his manner and conduct towards her, she is reasonably certain that he will commit such violence on her person, attended with danger to her life and health.

THIRD:

That there were born of this marriage between your Complainant and the Respondent the following named children, viz; Oren David Applequist, thirteen years of age, and Juanita Joan Applequist, eleven years of age. That your Complainant is a fit and proper person to have the care, custody and control of such children. That your Complainant has no money or property with which to properly support and educate such children and the Respondent is able to pay your Complainant such sufficient amounts to properly support and educate such children.

PRAYER FOR PROCESS AND RELIEF:

The premises considered, your Complainant prays that the above named Cren V. Applequist be made a party Defendant to this cause by the usual writ or process of this Honorable Court requiring him to appear and plead, answer or demur within the time and under the penalties prescribed by the rules of this Court and the Statutes in such cases made and provided; that upon a final hearing of this cause that your Honor will award your Complainant custody and control of her minor child ren herein named and will order and decree that your Honor shall pay your Complainant the sum of Twenty-five (\$25.00) Dollars a week as support for such children, except during the period when the children are in his custody and care. That your Honor will also grant unto your Complainant an absolute divorce from said Respondent and will decree that the parties be allowed to remarry if they see fit.
