Since we were married he has been drinking constantly and has become addicted to hatitual drunkenness, and this habit and his drunkenness is still continuing. There are no children of this marriage, and I was compelled to separate from Elmer Horn on or about the 18th day of August, 1955, as a result of his becoming addicted to habitual drunkenness.
