DEPOSITION OF LOLA ALLDAY

WITNESS FOR COMPLAINANT

Said witness having been first duly sworn testified as follows:

LOLA ALLDAY

I am the Complainant in this case; I am over the age of twenty-one years and a lifelong resident of Baldwin County. My husband, who is also over the age of twenty-one years, and I were married about twelve years ago in Baldwin County and lived together in this County up to about two years ago when he commenced mistreating me. During this period, four children were born to us, Bennett, a son now 11 years old, Hazel 9, Marie 7 and Allie Mae 2. On a number of occasions my husband has beaten me so cruely that my body would be livid with bruises. His behavior became so violent that I finally left him and went to live with my parents. My husband then took the four children and turned them over to the care of his brother's wife at Leroy, Alabama. He now lives at St. Stephens, Alabama and works at the Gulf Shipbuilding Co. in Chickasaw. I do not dare to return to my husband because of his cruelty and the many beatings he has given me.

She would come to my house after he had mistreated her and tell me how cruel he was to her. I told my husband of this and he got after Allday who promised to do better. He did not however but told Lola that it did not make any difference what he told her father, that if she did not do exactly as he told her he would beat her agaim. He did beat her after this and she came back home and has been living apart from her husband ever since. She is very properly afraid bf her husband and has a right to be from the way her body showed the blows he has given her.

to the care and support of said children whose custody she prays.


THE FREMISES CONSIDERED, Complainant prays that S. T. Allday be made party defendant to this cause and by proper process

required to answer this Bill within the time prescribed by Lew.


