We were married on August 31, 1954 at Eucedale, Mississippi and lived together as husband and wife until on or about July 15, 1955 at which time I was forced to leave him because of his threats and mistrestments of me and because he had constantly been getting worse in his threats so that when he threatened me that day I was in fear of my life or health and forced to leave him. He then threatened me again in writing and I know I could never live with him again as husband and wife. There was one child born as fruits of this marriage Rebecca Ann now age about eight morths. I respectfully submit to this Honorable Court that I am a fit suitable and proper person to have her care custody and control as I have had her care custody and control since her birth. There is no property to be divided.

Down of Parker

That my name is Ernest Hadley, I know both parties to this cause, Dorothy Hadley Parker is over the age of 18 and has been a resident of Alabama more than two years next preceding. They were married at Lucedale, Mississippi on August 31, 1954 and lived together as husband and wife until July 15, 1955 but were separated at times during this period. On or about July 15, 1955 because of the threats made by the Respondent against her person, Dorothy Hadley Parker became in fear of her life or health and left him. I have seen a letter since that time where Gordon Parker threatened her again so I know that she was in fear of her life or health as she left the community where she lived. Eccause of these threats I do not believe that she will ever live with him as husband and wife any more. There is no property to be divided. I do believe that she is a fit suitable and proper person to have the care custody and control of a little daughter Rebecca Ann born during this marriage.
