- Q. This is Mr. Ort H. Ertzinger?
- A. Yes sir.
- Q. Mr. Ertzinger, you are over 21 years of age?
- A. Yes sir.Q.
- Q. And a resident of Baldwin County, Alabama?
- A. Yes sir.
- Q. Do you personally know the two Respondents, Walter and Mildred Spxi
- A. I do not.
  - e. But if they are living, could you testify that they are over 21 years of age?
- A. Yes.
- Q. Mr. Ertzinger, have you made any effort in the last few months to locate Walter Splitt and Mildred Splitt?
- A. Yes; I went to their home in Hammend Indiana in August and went to the Lawyer who represented Mr. Splitt, and the lawyer was dead, and they didn't know anything about him in the office, and I went to where Mr. Walter Splitt had lived

And he had moved and I couldn't locate either of the Respondents; apparently, they didn't live in Hammond.

- Q. Are you in the actual, peaceable possession of the lands described in the bill of complaint in this cause, that is, the NW4 of SE44 Section 28, Township 6 South, Range 3 East
- A. Yes sir.
- Q. Will you tell the Court what possession you have had of this property since you bought it on the 24th day of September, 1951?
- A. Immediately after I bought it I went to see the property and went all over it and later on I sold xx off all of the timber on the land.
- Q. Do you remember what year you sold the timber?
- A. I think it was a little over six months after I bought the property.
- Q. Mr. Ertzinger, have you and Ralph Splitt, the person from whom you purchased this land, paid the taxes on this property for the past 10 years?
- A. Yes sir.
- Q. Have you and Ralph J. Splitt, the person from whom you purchased the property, been in the peaceable possession of this
  property for 10 years immediately preceding the filing of
  this bill of complaint?
- A. Yes.
- Q. You are claiming title the unincumbered, fee simple title, to all of this property by virtue of the deed from Ralph J. Splitt to you, dated September 24, 1951, which deed is recorded in Deed Book 171, at page 260 in the office of the Judge of Probate of Baldwin County, Alabama?
- A. Yes sir.

- Q. I believe you said you have made a diligent search for any one who might claim any title to this property, or any firm or corporation who might be making any claim to it?
- A. That is right.
- Q. You have had an abstract made of this property?
- A. Yes sir.
- Q. Are all of the facts you have ascertained, and everything you have been able to ascertain about the property, as set out in your bill here?
- A. Yes sir.

- Q. Did the old man, George Splitt, have any children?
- A. Yes sir, he had two children; Walter Splitt and Mildred Splitt.

  George's wife xxxx ran off with the two children with another

  man and George died of a broken heart.
- Q. And Ralph Splitt was a nephew?
- A. Yes sir.
- Q. The two children of George Splitt, did you know them?
- A. No.
- Q. Do you have any idea where they are now?
- A. No. I tried to find them this summer.
- Q. By what right did Ralph Splitt Deed you the property?
- A. George Splitt left a will, willing it to Ralph.

- Q. Was that will Probated in Baldwin County?
- A. No.
- Q. When did Mr. Splitt die?
  - A. He died some time in 1943 -
