- l. That she is over the age of twenty-one and is a bona-fide resident of Baldwin County, State of Alabama, and has been for 1 year next preceeding filing of this suit.
- 22. That NICHOLAS J. QUINLAN is over the age of twenty-one and is a resident of New York City, New York.
- 3. That your complainant and respondent were lawfully married in New York City, New York, the 18th day of June, 1946.
