This cause coming on to be heard is submitted upon the verified petition of VIRGINIA WATERS DAW, as Mother of IDA L. WATERS, a Minor over the age of eighteen years, for the removal of the disabilities of non-age of the said IDA L. WATERS, the order of this Court directing the Sheriff of Baldwin County, Alabama, to serve a copy of said petition upon the said IDA L. WATERS, and setting this cause down for hearing on affidavits on this date, the return of the Sheriff of Baldwin County, Alabama, showing service of a copy of the said petition upon the said IDA L. WATERS, and the Affidavits of J. C. McLEOD AND ALFRED BILLY;

And the same being considered and understood by the Court and the Court finding that the facts stated in the said petition are true; that the said VIRGINIA WATERS DAW resides in Baldwin County, Alabama, near Old Gateswood, Alabama; that the said IDA L. WATERS resides with the Petitioner; that the Father of IDA L. WATERS is dead and that she, the said IDA L. WATERS, is over the age of eighteen years and will reach her twenty-first birthday on, to-wit, the 9th day of December, 1955; and the Court being satisfied that it will be to the best interest of said minor to be relieved of the disabilities of non-age, and no objections being filed to the granting of said petition, it is, THEREFORE,

CONSIDERED, ORDERED, ADJUDGED AND DECREED that the prayer of said petition be and it is hereby granted; that it will be to the best interest of the said minor, IDA L. WATERS, to be relieved from the disabilities of non-age unconditionally and without restriction.

It is further CONSIDERED, ORDERED, ADJUDGED AND DECREED that the said IDA L. WATERS be, and she is hereby, relieved from the disabilities of non-age unconditionally and without restriction and that she be and hereby is invested with the right to sue and be sued, contract, buy, sell and convey real estate and generally to do and perform all acts which she could lawfully do if twenty-one years of

age; that a duly certified copy of this decree be filed for record in the Office of the Judge of Probate of Baldwin County, Alabama; and that the Petitioner pay the costs in this behalf incurred, for which let execution issue.

WATERS of the filing of this petition, and of the day set to hear and determine the same, in manner as provided by law; and upon the hearing hereof may it please the Court to make and enter a decree unconditionally relieving the said IDA L. WATERS of the disabilities of non-age; and that this Honorable Court make all such orders and decrees in the premises as to it may seem just and proper.
