

That in and by the terms of said note, the Defendant agreed to pay all costs of collection, including a reasonable attorney's fee, and the Plaintiff now claims the further and additional sum of ONE HUNDRED AND 80/100 (\$180.00) DOLLARS as a reasonable attorney's fee.

That in and by the terms of said note, the Defendant waived all rights of exemption under the Constitution and Laws of the State of Alabama, and the Plaintiff now claims the benefit of said waiver.


