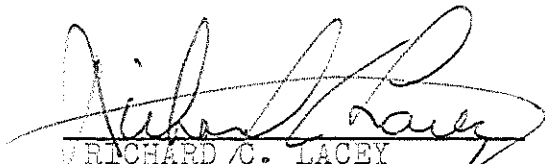
BILL OF COMPLAINT
