

The Plaintiff claims of the Defendant the sum of THREE HUNDRED TWENTY AND 90/100 DOLLARS (\$320.90), the balance due upon a note executed by the Defendant on the 4th day of September, 1968, in the amount of \$360.00, and payable in 24 monthly installments of \$15.00 each, the first installment to become due on October 4, 1968, with interest thereon at the rate of 8% per annum, from December 4, 1968; Plaintiff further alleges that in and by the terms of said note the failure to pay any installment accelerated the balance due under said note, and that said Defendant defaulted in his obligation to pay the installments as set out hereinabove.

Plaintiff further alleges that in and by the terms of said note, the Defendant waived all rights of homestead under the laws of the State of Alabama, and Plaintiff claims the benefit of said waiver.

Plaintiff further alleges that in and by the terms of said note the Defendant agreed to pay all costs of collection, including a reasonable attorney's fee, and Plaintiff claims the benefit of such attorney's fee.
