Now comes the Respondent in the above styled cause, by his Attorneys and demurs to the Bill of Complaint heretofore filed against him in said cause and to each and every aspect thereof and assigns the following separate and several grounds:

1. That said Complaint fails to state a cause of action.
2. That said Complaint fails to allege a ground to support the relief prayed for.
3. That the allegation "that the said parents of the Respondent are not physically able to care for the said baby" is but a conclusion of the pleader.
4. That the allegation that the baby "is badly in need of a mother's care" is but a conclusion of the pleader.
5. That it affirmatively appears from said Complaint that the Complainant had abandoned the minor child, Norman Lee Floyd and had left the child in the home of her mother.
6. That the allegation "when the Respondent by force took the baby" is but a conclusion of the pleader and there are no facts alleged to support such conclusion.
7. For aught that appears from the Complaint the Complainant is unfit to have the care, custody and control of the minor child, Norman Lee Floyd.
8. That the allegations contained in paragraph four of the Bill of Complaint are mere surplusage.
9. That said Complainant does not offer to do equity.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the costs in this proceeding, become a part of and be taxed along with the original proceeding.

TO HONORABLE TELFAIR J. MASBURN, JR., JUDGE OF THE CIRCUIT COURT OF  
BALDWIN COUNTY, ALABAMA: IN EQUITY:

Your Complainant Beulah Mae Floyd, respectfully represents unto  
your Honor and this Honorable Court as follows:

1.

That your Complainant and the Respondent are both over twenty-one  
years of age and bona fide residents of Baldwin County, Alabama.

2.

That your Complainant and the Respondent married in Lucedale, Mississippi,  
on May 31, 1950, and lived together as husband and wife in Baldwin County,  
Alabama, until June 29, 1951.

3.

That on to-wit June 29, 1951, and on various occasions prior thereto,  
while your Complainant and the Respondent were living together as husband  
and wife, the Respondent threatened and abused your Complainant and often  
threatened to do violence to her person which would necessarily endanger  
her life and health; that the conduct of the Respondent was such as to  
give your Complainant every reasonable apprehension to believe and she does  
actually believe that if she continues to live with him he will carry out  
his threats and do violence to her person which would necessarily endanger  
her life and health.

4.

That your Complainant and the Respondent have one child, Norman Lee Floyd, who remained in the custody of your Complainant, until Thursday night, July 26, 1951, when the Respondent by force took the baby from the home of the mother of your Complainant, and has kept him since that time; that the baby is now and has for some time been suffering with infantigo and is badly in need of a mother's care; that it is to the best interest of the said minor child that he be immediately restored to the custody of his mother, your Complainant; that the Respondent lives with his mother and father, his father being around 80 years of age and his mother 65 years of age; that the said parents of the Respondent are not physically able to care for the said baby.

5.

That the Respondent is an able bodied man working at Brookley Field, Mobile, Alabama, earning \$50.00 per week and more; that the Complainant has no property or means of raising money with which to prosecute this action.

WHEREFORE, the premises considered, your Complainant prays that Your Honor will by proper process make the said Charles Floyd party Respondent to this cause of action requiring him to plead, answer or demur to the same within the time and under the penalties prescribed by law and the practice of this Honorable Court;

That Your Honor will enter an order and decree requiring the Respondent to immediately surrender the custody of the minor child Norman Lee Floyd to his mother, your Complainant; that in the event the Respondent should fail to comply with the decree of the court that an order and decree be made and entered authorizing, directing and empowering the Sheriff of Baldwin County, Alabama, to take into his custody the minor child, Norman Lee Floyd and immediately return him to the custody of his mother, your Complainant; that Your Honor will order a reference to determine a reasonable amount to be paid by the Respondent to your Complainant as alimony pendente lite and attorney fees.

Your Complainant further prays that upon a final hearing hereof Your Honor will make and enter an order and decree forever divorcing her from the bonds of matrimony existing between her and the Respondent; that she be awarded the permanent custody of the minor child, Norman Lee Floyd; that

she be awarded such amounts as to Your Honor shall seem just and proper as permanent alimony, for the maintenance of herself and the minor child; that Your Honor will award to her such other, further, different or general relief as she may be in equity and good conscience entitled to receive.
