The Respondent about November 19, 1948, struck me with a "blackjack,". The conduct of the Respondent, toward me is such as to give me every reasonable apprehension to believe, and I do actually believe that if I continued to live with him, he will carry out his threats and do further violence to my person, which will necessarily endanger my life and health.

The Respondent and I have never been able to get along. His conduct toward me, has been such, during our married life, and has got to the point to render it absolutely impossible for us to live together as husband and wife.

The Respondent and I have no children, nor do we have any property.

The Respondent during the past twelve months has been spending practically all of his time in Mobile, and comes hom some week ends, and on practically every visit home, he has been drinking, and threatens and abuses me. I have since last February been compelled to work for myself.

I know that conditions are such, and I have done my best to overcome them, however, there is no chance for the Respondent and I do live together as husband and wife.
