TO THE HONORABLE FRANCIS W. HARE, JUDGE OF THE TWENTY-FIRST JUDICIAL GIRCUIT, BAY MINETTE, BALDWIN COUNTY, IN EQUITY SITTING:

Comes the Complainant, Mamie Valree Donald, who shows unto your Honor the following state of facts:

- l. That your Complainant and Respondent are both over the age of twenty-one years of age and at the time of their separation were residents of Baldwin County, Alabama.

- 3, The Complainant further shows unto the Court that she has lived separate and apart from the bed and board of Frankie Donald, her said husband, for more than two years and without support from him for more than two years next preceding the filing of this bill and during said period she has been a bona fide resident in the State.
 - 4. There are no children as fruit of this marriage.

 PRAYER

WHEREFORE, the premises considered the Complainant prays that Your Honor by proper process, make the said Frankie Donald, party respondent to this cause of action, requiring him to plead, answer or demur to the same within the time and under the penalties prescribed by law and the practice of this Honorable Court.

Complainant further prays that on the final hearing of this complaint, together with proofs submitted with the same that your Honor will grant unto her an absolute divorce, forever dissolving the bonds of matrimony existing between her and the Respondent, and at the time of making this decree,

Your Honor will grant each of them the right to again contract marriage; that your Honor will grant unto your Complainant the right to resume her maiden name of Mamie Valree.
