

TESTIMONY OF THOMAS J. EARLE

My name is Thomas J. Earle; I am more than twenty-one years of age. I reside in Baldwin County, Alabama. I am acquainted with the lands involved in this suit and I own an undivided 11/12 interest in the same and have owned the same for more than three years. The Respondents, Jonas Harris, David Harris, Sarah Harris James, Susie Harris Tunstall, Lamb Harris, Elizabeth Harris Clemmans, Alice Harris Williams, Linnie Mae Harris Owes and Solomon Harris, each owned an undivided 1/96 interest in said land subject to the ourtesy of Jonas Harris. That all of the parties to this suit are over the ages of twenty-one years. That Solomon Harris was at one time in the Armed Services of the United States of America but from information that I have he has been discharged by the Army authorities and from such information and belief that I have I herein state that he is no longer in the Armed Forces of the United States of America; That none of the other Respondents were at the time of the filing of the Bill of Complaint in this cause nor now in the Armed Forces of the United States of America. That the lands involved are swampy,
