The Respondent and I married at Bay Minette, Alabama, on August 15, 1944. We lived together as husband and wife until August 19, 1949.

The Respondent on and prior to August 19, 1949, often threatened and abused me and on several occasions did actual violence to my person by striking me. His conduct toward me was such as to given me every reasonable apprehension to believe and I did actually believe that if I continued to livewith him, he would carry out his threats and do further violence to my person which would necessarily endanger my life and health.

I have on three occasions prior to August 19, 1949, on account of the cruel treatment on the part of the Respondent had to leave him, however, each time decided to go back in an effort to make a go of it, however, each time have failed. I know from past experiences that it is absolutely impossible for me to live with the Respondent. I cannot any longer put up with or endure his cruel treatment of me, and his threats toward me.

We have one child, Charles Cedric Green, who is now four years old and is living with me.

I am now, as I have each time the Respondent forced me to leave him, living with my father and mother. They are perfectly agreeable that my child and I live in the home with them.

My sister Sarah Nell Skipper has a number of time heard the Respondent threaten me and has seen him commit actual violence on my person. There are several other persons that have also heard him threaten me and seen him strike me. I am absolutely positive that I cannot live with the Respondent any longer.

My name is Sarah Nell Skipper. I am a sister of the Complainant Annie Mae Green. My sister and the Respondent have been living near us and I have had an occasion to be with and see them during the time they have been married.

I know that the Respondent has often threatened my sister, and that on different occasions he has committed actual violence to her person by striking her. My sister and the Respondent on account of the mistreatment of my sister on the part of the Respondent have separated on three occasions prior to the last time, and each time my sister has returned to live with him in an effort to get along. I know that the Complainant and the Respondent cannot get along.
