2. Rinehold P. Klug, as Guardian of Ramona Klug Vincent and Arlan Klug, and the surety on his bond as such Guardian shall be and they are hereby relieved of and discharged from all

other and further liability because of the said guardianship.

3. The costs of this proceeding amounting to \$34.65
