It is therefore ordered, adjudged and decreed by the Court that the bonds of matrimony heretofore existing between the Complainant and Defendant be, and the same are hereby, dissolved, and that the said LUVERT BROOKS is forever divorced from the said FRANKLIN BROOKS for and on account of Separation from bed and board for more than two years

It is further ordered, adjudged and decreed by the Court that the care, control and custody of the two minor children, Benjamin Brooks and Lawrence Brooks be in the Mother, Luvert Brooks the complainant in this cause, until further orders of this Court.

It is further ordered, adjudged and decreed that neither party to this suit shall again marry except to each other until sixty days after the rendition of this decree, and that if appeal is taken within sixty days, neither party shall again marry except to each other during the pendency of said appeal.

It is further ordered that the Complainant and Respondent be, and they are hereby permitted to again contract marriage upon the payment of the cost of this suit.

It is further ordered that Luvert Brooks the Complainant pay the cost herein to be taxed, for which execution may issue.

I, Bobby Lucile Jackson, as register and commissioner have called and caused to come before me, Luvert Brooks and Maziabelle Barnett, witnesses named in the Requirement for Oral Examination on the second day of October, 1951, at the office of Bobby Lucile Jackson, in Foley, Alabama, and having first sworn said witnesses to speak the truth, the whole truth, and nothing but the truth, the said Luvert Brooks and Maziabelle Barnett doth depose and say as follows:

My name is Luvert Brooks. I am twenty-three years of age and a resident of Baldwin County, Alabama. Franklin Brooks is over the age of twenty-one years and is a resident of Baldwin County, Alabama. Franklin Brooks and I were married May 7, 1944 at Foley, Alabama. We have two children, Benjamin Brooks who is six years old and Lawrence Brooks who is five years old. I have been a resident of Alabama all of my life.

Sometime before Lawrence was born my husband started running around with another girl and not coming home like he ought to. We had several arguments and finally I took Benjamin and went to my Mother's house. That was sometime in April, 1946. Since that time I and the children have lived with my Mother and I have worked for our living. My husband has not given me or the children anything for our support or welfare since I left him nor have we had anything to do with each other since then.

Luvert Brooks

My name is Maziabelle Barnett. I am over twenty-one years of age and live in Foley, Alabama. Luvert Brooks is my sister. Back in 1946, just before Lawrence was born, Luvert and Franklin separated and Luvert came home to live with our mother. To my knowledge Luvert has not had anything to do with Franklin or lived with him since then. Franklin has not given her anything for the support of herself or their children either since then. Luvert has had to work to take care of them and pay all of the bills.

Mazi Bell Barnett

Your complainant, Luvert Brooks, respectfully represents and shows unto your Honor:

1. That the complainant is over the age of twenty-one years and is a resident of said State and County, and has been a bona fide resident of said state for more than two years next preceding the filing of this bill of complaint; that Franklin Brooks is over the age of twenty-one years and is a resident of Baldwin County, Alabama.

2. That your complainant and respondent were lawfully married on or about to-wit; May 7, 1944, at Foley, Alabama, and of this marriage two children have been born, Benjamin Brooks, six years old and Lawrence Brooks, five years old.

3. The Complainant further shows unto the Court that she has lived separate and apart from the bed and board of Franklin Brooks her husband for two years next preceding the filing of this bill of complaint and without support from him for herself or their children during said two years and further that she has been a bona fide resident of Alabama during said period.

The premises considered, your complainant makes the said Franklin Brooks a party respondent to this bill of complaint, and in order that the complainant may have the relief herein prayed for, may it please your Honor to cause the State's writ of subpoena to be issued, directed to the said Franklin Brooks, Commanding him to answer, plead or demur to this bill of complaint, within the time required by law; and that on a final hearing of this cause, that your Honors will enter a decree divorcing your complainant from the said respondent, granting the complainant the right to remarry and granting the complainant the care, control and custody of the two minor sons of the parties; and that your Honor will grant such other, further and different relief as unto your Honor may seem just and proper, and your complainant will ever pray.
