This cause coming on to be heard was submitted for decree on the petition of Mary E. Hinterliter, the mother of Barbara Ann Hinterliter, and the ex parte affidavits of S. W. Langston and C. A. Bodden.

The Court after considering the petition and the facts set out in the said affidavits is of the opinion that the said Barbara Ann Hinterliter possesses sufficient knowledge and ability to manage and control her own affairs.

It is, therefore, ordered, adjudged and decreed, by the court, that Barbara Ann Hinterliter, who is twenty years of age, be, and she is relieved of the disabilities of non-age, and vested with the power to sue and be sued, contract and be contracted with, to receive and take possession of any real and personal property to which she is entitled; to purchase real or personal estate; to sell and convey; and to do all things, and to all intents and purposes as effectually as if she was twenty-one years of age.

IT IS FURTHER DECREED that the said Mary E. Hinterliter pay the costs of this proceedings, for which execution may issue.




