My name is R. C. Keeney. I am a bona fide resident of Baldwin County, Alabama, and over twenty-one years of age. The Respondents, Maude Kellerman Swingle, J. E. Naylor, Lillian N. Braden, Alice Church, W. Y. Church, E. S. Braden and E. S. Draden if living are non-residents of Baldwin County, Alabama, and over twenty-one years of age, and if dead their heirs are all over twenty-one years of age are non residents of the State of Alabama. The Farmers Savings and Trust Company is a foreign corporation and has no agent within the State of Alabama upon whom service can be perfected. I have lived in Baldwin County, Alabama, for more than twenty-five years, and have from time to time visited in and worked in the territory in which the lands involved in this suit are located. I know that for more than twenty-five years neither of the named respondents have lived in Baldwin County, Alabama. I have made inquiries at Silverhill, Robertsedale, Loxley, and other sections of the county and have been unable to get any information as to the said respondents.


I am the owner and in the actual possession of the lands described in the bill of complaint and being the Southeast quarter of Southeast quarter of Southeast quarter, South half of Southwest quarter of Southeast quarter of Section 22, Township 5 South, Range 3 East.

I had made a search of the records to determine the names of any and all persons having any claim against the said land and they are as listed in the bill of complaint.

There is no suit pending to test my title to, interest in or rights of possession to said lands. I acquired title to the said lands from E. S. Braden by State Land Commissioner on October 11, 1944, by deed of record in Deed Book 87 NS pages 240-1, from Agnes E. Utter on April 13, 1944, by a deed of record in Deed Book 82 NS page 447 and Maude Kellerman Swingle by State Land Commissioner on July 18, 1945, by deed of record in 93 NS page 498 and from Farmers Savings and Trust Company, Administrator of the estate of W. Y. Church by State Land Commissioner on July 18, 1945, of record in Deed Book 93 NS page 492. All of said deed being of record in the office of the Probate Judge of Baldwin County, and a copy filed herewith and asked to be taken in connection with this testimony.

The title to the said land stands upon the records of the Probate Court of Baldwin County, Alabama, in my name. No one has at any time within ten years next preceding the filing of the bill of complaint in this cause paid any taxes upon said land or any part thereof or had any possession of the said land or any part thereof other than Agnes E. Utter and me. The only persons known to claim an interest in said land are the respondents named in the bill of complaint. All of the land is under fence having been fenced by me through my agent for the past three or four years.

No one has for many years attempted to exercise any claim to the said land other than a small parcel thereof by Agnes E. Utter from whom I have a deed.

I had occasion to be upon the land about three years ago and the lands involved were at that time under fence and have been until this date.
