The premises considered, your Complainant makes the said Annie Lee Tate a party respondent to this Bill of Complaint, and in order that Complainant may have the relief herein prayed for, may it please your Honor to cause the State's writ of subpoena to be issued, directed, to the said Annie Lee Tate commanding her to answer, plead or demur to this Bill of Complaint, within the time required by law; and that on a final hearing of this cause,

that your Honor will enter a decree divorcing your complainant from said Respondent, granting the Complainant the right to remarry; and that your Honor will grant such other, further, and different relief as unto your Honor may seem just and proper.
