Now comes the Respondents, and without waiving their demurrer heretofore filed in this cause and insisting thereon, files the following answer.

1. They admit that the Complainants are both over 21 years of age and bona fide residents of Baldwin County, Alabama.

That the Respondents are both over the age of 21 years of age and residents of Mobile County, Alabama, rather than Baldwin County, Alabama.

2. They deny all of the allegations contained in paragraph Two, and demand strict proof thereof.

And further answering paragraph Two, the Respondents say that they are the owners of and in the actual possession of said lands and were in the actual possession thereof at the time the suit was filed in this cause.

3. The Respondents allege, in answer to paragraph three, that they are the owners in fee simple, and in the actual possession of said lands described in the bill of complaint, and were the owners and in the actual possession of said lands on the day this suit was filed.

And for further answer to the complainants' bill of complaint the respondents say that on June 7, 1951 Sam Jacoby and Rudolph Jacoby, as Plaintiffs, filed suit in ejectment, in the Circuit Court of Baldwin County, Alabama, being cause No. 1671, against Boss Thompson and Rett Thompson, as defendants, the said Plaintiffs and defendants being the same parties in this suit, which complaint was executed by service on the said defendants on June 14, 1951; that the following judgment was entered in and by the Circuit Court of Baldwin

County, Alabama, at law, in said cause: "12-18-51 Judgment by default in favor of the Plaintiffs and against the defendants for the lands sued for in the complaint. Writ of possession ordered. Telfair J. Mashburn, Jr. Judge."

The Sheriff's return in said cause shows: " Executed ~~7-14-52~~ by delivering the within described property to Sam Jacoby and Rudolph Jacoby. Taylor Wilkins, Sher. by: H.F. Hall".

That the present suit was filed in the Circuit Court of Baldwin County, Alabama, in equity, No. 2830, by Boss Thompson and Ret Thompson, Complainants, vs. Sam Jacoby and Rudolph Jacoby, respondents, and service perfected on the respondents on June 27, 1951.

That Boss Thompson and Ret Thompson, as Complainants, filed suit against Sam Decoby and Rudolph Jacoby, as Respondents, being the same parties to this present suit, in ejectment to recover possession of the lands described in the bill of complaint in this cause, being No. 1825, on the law side of the Court; that this suit was filed on July 3, 1952, and service perfected on July 5, 1952. That judgment was entered in said cause in the Circuit Court of Baldwin County, Alabama, at law, as follows: 10-20-52, Jury and verdict for the defendants. Telfair J. Mashburn, Jr., Judge."

Wherefore, the Respondents having fully answered, now pray that this cause be forthwith dismissed.

Your Complainants, Ross Thompson and Ret Thompson respectfully represents and shows unto Your Honor and this honorable Court as follows:

1.

That your Complainants are both over twenty one years of age and bona fide residents of Baldwin County, Alabama; that your Respondents are both over the age of twenty one years and bona fide residents of Baldwin County, Alabama.

2.

That your Complainants are the owners in fee simple and in the actual possession of the following ~~described~~ described lands, situated in Baldwin County, Alabama, having been in the actual, open and notorious possession of said lands, adverse to all the world, for a period of to-wit, twenty five years.
Description of said lands, to-wit: Beginning at the SW corner of lot 7, Block 1, Fort Morgan addition to Bay Minette, Alabama, as per plat of record in the office of the Probate Judge of Baldwin County, Alabama, in Map Book 1, page 127, thence southerly 50 feet to a point, place of beginning, thence southerly 200 feet along west line plot 6, Block 1, thence East 100 feet, thence Northeast 200 feet to a point, thence East 150 feet to place of beginning.

3.

That the Respondents are alleged to claim some right, title or interest in and to said property and the Complainants therefore calls upon the Respondents to set forth and specify what right, title or interest they have in or claim to said property and by what instrument the same is derived and or created.

That your Complainants on to-wit February 22, 1928 paid the purchase price of said land to Wallace McMillan now deceased, was put into possession of said land by the said Wallace McMillan under color of title and have remained in continuous and uninterrupted possession of said land since that time.

Wherefore, the premises considered, your Complainants pray that Your Honor will by proper proceeding make the said Sam Jacoby and Rudolph Jacoby, party Respondents to to this bill of complaint, requiring them to plead, answer or demur to the same within the time and under the penalties prescribed by law and the practice of this honorable court.

Your Complainants further pray that upon a hearing hereof, your Honor will make and enter a decree establishing the title of Your Complainants and to said lands and that the Respondents have no right, title or interest in or encumbrance upon the said lands or any part thereof; That your Honor will enter a decree granting unto your Complainants such other, further, different or general relief as they may be in Equity and good conscience entitled to receive and your Complainants offer to do such Equity in the premises as Your Honor may see fit to require, and in duty bound they will ever pray.


