THE PREMISES CONSIDERED: Your complainant prays that

Edward Henry Keith be made a party defendant to this cause by the

usual process of this Honorable Court, requiring him to plead,

answer or demur within the time and under penalties prescribed by

the rules of this Court and the statutes in such cases made and pro
vided; that upon a final hearing of this cause, that your complain
ant be granted a divorce from said respondent. And that she be

granted custody and control of the two minor children with rights of visitation to the respondent and that she be granted and awarded the sum of Seven Dollars and 50/100 cents (\$7.50) per week for the maintenance and support of each child.
