It is therefore ORDERED, ADJUDGED and DECreed by the Court that Barbara Ann Lazzari be, and she is hereby, relieved of the disabilities of non-age and invested with the right to sue and be sued, contract, buy, sell and convey real estate, and generally to do and perform all acts and deeds which she could lawfully do if she were twenty-one years of age.



Your Petitioner, Alexander V. Lazzari, respectfully shows unto this
Honorable Court and avers:

F I R S T

That he is over the age of twenty-one years and is a resident of
Baldwin County, Alabama.

S E C O N D

That he is the father of Barbara Ann Lazzari, a minor, over the age
of eighteen years; that Ada Lazzari, the mother of the said
minor, Barbara Ann Lazzari, is dead, and that the said minor has no legal
guardian; and that the said minor resides with her brothers and sisters in the
said County of Baldwin.

T H I R D
