Complainant believes her to be a fit and proper person to have custody and control of the said children, and believes himself to be financially able to pay the sum of Twenty-five Dollars (\$25.00) per month for the support and maintenance of each of the children during their dependency.

### PRAYER FOR PROCESS AND RELIEF

THE PREMISES CONSIDERED, your Complainant prays that Gladys Schaff be made a party defendant to this cause by the usual process of this Honorable Court, requiring her to plead, answer, or dumur within the time and under the penalties prescribed by the rules of this Court and the Statutes in such cases made and

My name is Patricia Schaff. I am sixteen years of age and the daughter of Lawrence Schaff and Gladys Schaff. They are both over the age of twenty-one years, and are both residents of Baldwin County, Alabama. On a number of occasions since my father and mother remarried, I have heard her threaten him with violence, have heard her threaten to kill him and believe that she firmly intends to do actual violence on his person, attended with danger to his life or health, and from her conduct toward him, I believe it to be reasonable for him to be apprehensive and for him to fear death or serious bodily injury. There is one more minor child of this marriage whose name is Sandra and who is nine years of age. I believe my mother, Gladys Schaff to be a fit and proper person to be charged with our custody.
