DECREE REMOVING DISABILITY OF NON-AGE OF SUDIE LEE McWHITE, A MINOR

This cause coming on to be heard upon the verified petition of Dorothy S. Stapleton as mother of Sudie Lee McWhite for the removal of disability of non-age of the said Sudie Lee McWhite, this being the day set to hear and determine said petition.

Now comes the Petitioner, and the testimony of witnesses having

been taken by affidavits, pursuant to the direction of the Court, and the Court finding that the facts stated in said petition are true; that the said Dorothy S. Stapleton resides in the City of Fairhope, Baldwin County, Alabama, and the said Sudie Lee McWhite resides with the Petitioner; that the residency of the father of the said Sudie Lee McWhite is unknown; that the said Sudie Lee McWhite is over the age of eighteen years and will reach her twenty-first birthday on, to-wit, May 16, 1958. And the Court being satisfied that it will be to the best interest of said minor to relieve her of the disabilities of non-age and that a copy of said petition and the decree or order of this Court having been served upon the said minor, Sudie Lee McWhite, by registered mail, at her temporary residence, Aspen School of Music, Aspen, Colorado, ad provided by law, and that no objections being filed to the granting of the said petition, it is, therefore,

Considered, ordered, adjudged and decreed that the prayer of said Petitioner be and hereby is granted, that it will be to the best interest of said minor, Sudie Lee McWhite, to be relieved of the disabilities of non-age unconditionally and without restrictions.

It is, therefore, considered, ordered, adjudged and decreed that the said Sudie Lee McWhite be and hereby is relieved of the disability of non-age unconditionally and without restrictions and that she be

and hereby is vested with the right to sue and be sued, contract, buy, sell and convey real estate, and generally to do and perform all actions which she could lawfully do if twenty-one years of age; that a duly certified copy of this decree be filed for record in the office of the Judge of Probate of Baldwin County, Alabama; that the Petitioner pay the costs in this behalf incurred.

WHEREFORE, your Petitioner respectfully prays to this Honorable Court to set this petition down for hearing and will direct the issuance of notice to the said Sudie Lee McWhite of the filing of this petition, and of the day set to hear and to determine the same, in the manner as provided by law; and that upon the hearing thereof, may it please the Court to make and enter a decree unconditionally relieving the said Sudie Lee McWhite of the disabilities of non-age; and that this Honorable Court will make all such orders and decrees in the premises as to it may seem just and proper.
