My name is MARY ELIZABETH LAZZARI, and I am bringing this suit for divorce against my husband, LOUIS HENRY LAZZARI.

I have lived all my life in Baldwin County, Alabama, and so has my Musband, LOUIS HENRY LAZZARI, and we are both still living in Baldwin County, Alabama-I am living in Daphne, Alabama, and Louis is living in Belforest, Alabama.

My husband and I were married in Daphne, Alabama, on the 18th day of July, 1953, and lived together as husband and wife, more or less happily, until about six or eight months ago, and since that time he has become quarrelsome and we cannot get along happily.
