TO THE HONORABLE H.M. HALL, JUDGE OF THE CIRCUIT COURT OF BALDWIN COUNTY, ALABAMA, SITTING IN EQUITY:

Comes your complainant, Bobbie W. Kerm, and respectfully shows and avers unto your Honor and the Court as follows:

- 1. That your complainant is over the age of twentyone years of age and is a bona fide resident citizen of
  Baldwin County, Alabama; that the respondent, Clermont
  J. Kern, is over the age of twenty-one years, and is a
  bona fide resident citizen of Baldwin County, Alabama.
- 2. That your complainant and the respondent intermarried in Folkston, Charlton County, Georgia, on, to-wit: April 12, 1957, and ever since have been and are now husband and wife.
- 3. Your complainant avers and charges that the said respondent did at divers times prior to the 5th day of July, 1957, and on or about the 5th day of July, 1957, act in an abusive, insulting and threatening manner toward your complainant; that the said respondent on the 5th day of July committed acts of physical violence in the presence of your complainant attended with danger to her health or life; that respondent has made numerous threats of doing her physical harm and from his manner and conduct toward her, she is reasonably convinced that he will commit actual violence upon her person, attended with danger to her health or life; that on, to-wit, the 5th day of July, 1957, she separated from and abandoned the said respondent, and is now living separate and apart from him.

THE PREMISES CONSIDERED, complainant prays that the respondent be made a party respondent to this Bill Of Complaint by the usual process of this Honorable Court, and the statutes in such cases made and provided, requiring him to plead, answer or demur within the time and within the manner provided by law; and that on a final hearing of this cause that your Honor will enter a decree divorcing your complainant from the said respondent, and granting both parties the right to remarry; and complainant further prays that your Honor will grant such other, further, different, and general relief to which the complainant may be entitled, as in duty bound she will ever pray.
