#### FIRST:

That he is over the age of twenty-one years and a resident citizen of Baldwin County, Alabama, his more particular address being postoffice box 401, Robertsdale, Alabama. That the Respondent is over the age of twenty-one years and is a non-resident of the State of Alabama, presently residing at 1638 South Halstead Street, Chicago Heights, Illinois.
