FOURTH: Your Complainant further avers and shows unto your Honor that there was born to the union of Complainant and Respondent five children. That two of these children are now minors, namely Irene McCurdy, a girl, age 16 years and Helen McCurdy, a girl, age 14 years. That said minor children are now in the care, custody and control of the Complainant, their mother, that said Complainant is a fit and proper person to be awarded the permanent care, custody and control of said minor children; further that the Respondent is not a fit and proper person to be awarded the care, custody and control of said minor children. That Respondent is an able bodied man with regular employment and is well able to help provide for and maintain said minor children.

FRATER FOR PROCESS

Wherefore the premises considered the Complainant prays that the said Burt McCurdy, be made party Respondent to this her Bill of Complaint and that a summons be issued and served upon him as required by law and the rules of this Ecocrable Court, and that she be required to plead, answer or demur to the within Bill of Complaint within the time and under the penalties prescribed by law and the rules of this Ecocrable Court.

PRAYER FOR FINAL RELIEF
