Comes now your Complainant and respectfully shows unto Your Honor as follows:

l.

That your Complainant and the Respondent are both over the age of twenty-one years and bona fide resident citizens of Baldwin County, Alabama.

2.

That your Complainant and the Respondent were lawfully married to one another on, to-wit, March 22, 1952, in Robertsdale, Alabama, and lived together as husband and wife until on, to-wit, August 19, 1956.

3.

That on, to-wit, August 19, 1956, the Respondent voluntarily abandoned the bed and board of your Complainant and has remained away voluntarily and continuously since that time.

L.

That there was born to the marriage between your Complainant and the Respondent two children, John David Cech, age 5, and Michael Allen Cech, age 2; that your Complainant is a fit and proper person to have the care, sustody and control of her minor children.

WHEREFORE, the premises considered, your Complainant prays that Your Honor will by proper process make the said John Cech III party respondent to this Bill of Complaint requiring him to plead, answer or demur to the same within the time and under the penalties prescribed by law and the practices of this Honorable Court.

Your Complainant further prays that on a final hearing of this cause, Your Honor will enter a decree granting your Complainant a divorce from the Respondent and granting her the right to remarry; Your Complainant further prays that Your Honor will by said decree grant her the permanent care, custody and control of her minorchildren, John David Cech and Michael Allen Gech; Your Complainant further prays for such other, further, or different relief to which the Complainant may in equity be entitled.
