and before the suit was completed, Lillie Ruffin became a non compos mentis and it was necessary to hold an inquisition and on hearing and after Lillie Ruffin was declared a non compos mentis, it was necessary to revise the suit and complete it and I feel that a reasonable fee for that work would be between \$150.00 and \$200.00.




